

Regulations Governing Implementation of Scholarships for Mainland Chinese Students Pursuing Master's and Doctoral Degrees at Yuan Ze University

Passed at the 14th Administrative Meeting of 2011 dated May. 14, 2012

Revised and passed at the 17th Administrative Meeting of 2015 dated Apr. 27, 2015

Revised and passed at the 16th Administrative Meeting of 2016 dated Mar. 29, 2017

Article 1: The Regulations Governing Implementation of Scholarships for Mainland Chinese Students Pursuing Master's and Doctoral Degrees at Yuan Ze University (hereinafter referred to as the Regulations) are established to encourage excellent Mainland Chinese students to study at the University, facilitate an internationalized academic environment, and assist students in learning and studying diligently.

Article 2: Eligibility:

1. Applicants must adhere to the "Regulations for Mainland Chinese Students Studying in Taiwan for Higher Education."
2. Students must have completed at least one semester of coursework with a minimum of six credits per semester, achieving a GPA of at least 75 in the previous semester, and be recommended by their department. For Master's and Doctoral students who have not met the six-credit requirement while writing their thesis, they may apply with a recommendation from their advisor.
3. Students must maintain good conduct throughout their academic program, with no record of admonishment or higher disciplinary actions.
4. Students should not have applied for any other internal scholarships during the current semester.

Article 3: Scholarship Content and Duration:

1. Scholarship content includes tuition and miscellaneous fee waivers, as well as a stipend.
2. The maximum duration for Master's students is four semesters, and eight semesters for Doctoral students. Stipend is provided from the actual month of enrollment until the end of the scholarship period, which must be continuous without interruption.

Article 4: Application Procedure and Review:

Recommendations from departments (or equivalent academic units) are submitted before

the end of each semester, reviewed and approved by the Global Affairs Office to be eligible for the scholarships outlined in Article 3, Section 1.

Article 5: Suspension and Cancellation of Scholarships:

1. Scholarships are discontinued upon graduation, suspension, withdrawal, transfer, or cancellation of the scholarship.
2. If a student is found to have forged or provided false documents, their scholarship eligibility is revoked, and any funds received must be repaid.
3. Scholarships are suspended if the student is not in the Republic of China (R.O.C) for more than two months during a semester.

Article 6: The allocation of scholarship slots and the amount of stipend for Mainland Chinese students are flexibly adjusted according to the annual budget.

Article 7: After enrollment, Mainland Chinese students are required to adhere to the relevant regulations of the university. Violations may lead to the withdrawal of scholarship privileges after approval by the Global Affairs Office.

Article 8: These regulations are effective upon announcement after approval by the administrative council. Amendments follow the same procedure.

In the event of discrepancies between the English and Chinese versions, the Chinese version shall prevail.
