

# **Yuan Ze University Regulations Governing the Selection of Outstanding Alumni**

Approved by the 6th Executive Council Meeting of the 2008 Academic Year on November 24, 2008.

**Article 1** The "Yuan Ze University Regulations Governing the Selection of Outstanding Alumni" (hereinafter referred to as "the Regulations") are enacted to recognize outstanding alumni for their contributions to the University and society, enhancing the University's reputation and inspiring future generations.

**Article 2** Graduates or attendees of the University meeting any of the following qualifications are eligible for nomination as Outstanding Alumni candidates:

1. Exceptional achievements in their profession or business.
2. Significant contributions to society.
3. Major contributions to the construction or development of this University.

**Article 3** Nomination Methods:

1. Nominations by the Alumni Association, regional alumni associations, or departmental alumni associations.
2. Nominations by colleges or departments (institutes).
3. Nominations by members of the Selection Committee.
4. Nominations jointly endorsed by five or more alumni.

**Article 4** Selection Procedure:

1. The "Outstanding Alumni Selection Committee" of 9 - 15 members are appointed by the President, comprising internal and external individuals and alumni representatives. The Vice President serve as the Chairperson. Any Selection Committee member nominated as a candidate for that year shall recuse themselves from the process.
2. The selection requires a quorum of over half the committee members, with candidates needing two-thirds approval from those present to be recognized as Outstanding Alumni.
3. No more than five alumni may be selected as Outstanding Alumni each year.

**Article 5** The selection committee will announce the schedule for the selection process. Nominating units must submit nomination forms within the designated timeframe for processing by the Selection Committee. The list of candidates and the nomination and evaluation process shall remain confidential.

**Article 6** Outstanding Alumni shall be publicly honored by the President at significant University events, where they will be presented with an Outstanding Alumni award and certificate. Their achievements shall be published in the university's publications and on social media platforms to highlight their contributions.

**Article 7** Outstanding Alumni are expected to actively promote the University's educational philosophy and achievements and contribute to its advancement.

**Article 8** An Outstanding Alumni who engages in conduct detrimental to the reputation of the University may have their status revoked upon resolution by the Selection Committee.

**Article 9** These Regulations take effect upon approval by the Executive Council Meeting. The same procedure applies to any amendments.

In case of any discrepancy between the Chinese and English versions, the Chinese version shall prevail.
