

# **Yuan Ze University Gender Friendly Dormitory Assistance**

## **Regulations**

January 02, 2025 Approved by the 5th Student Affairs Meeting of the 2024 Academic Year

### **Article 1: Purpose**

To protect the accommodation rights of students with diverse gender identities, and in accordance with relevant regulations, these regulations are established to provide an inclusive, respectful, and safe living environment.

### **Article 2: Content of Assistance**

#### **1. Provision of Gender Friendly Accommodation Information**

Yuan Ze University (hereinafter referred to as "the University") collaborates with off-campus buildings to plan a gender friendly accommodation zone, dedicated to providing a safe and comfortable living environment. During the students' residence period, the university will conduct regular inspections of relevant safety facilities. Students should comply with the accommodation regulations set by the buildings and maintain good conduct, respect public order, ensure a peaceful living environment, and pay attention to hygiene.

#### **2. Consultation Service**

All students of the university can proactively contact the Student Housing Service Section (hereinafter referred to as "SHSS") to enquire about gender friendly accommodation information and receive relevant safety advice that complies with the "Gender Equality Education Act" and other relevant regulations. The SHSS will assist students in evaluating and understanding accommodation options that best meet their needs.

### **Article 3: Application Eligibility and Review Mechanism**

#### **1. Application Eligibility**

This assist mechanism applies to students with diverse gender identities who have been granted accommodation eligibility. To verify eligibility, applicants must provide supporting documents demonstrating incongruence between their biological and psychological gender identities, such as medical diagnoses related to gender or recommendations from professionals.

#### **2. Review Process**

Applicants should submit their applications to SHSS along with the required

supporting documents before the application deadline. When necessary, SHSS will collaborate with relevant departments to review applications, ensuring compliance with the mechanism's regulations and safeguarding the rights of all resident students.

### 3. Review Mechanism

The review process will be conducted in accordance with the principles of safeguarding student rights and providing appropriate assistance, adhering to relevant laws and university policies to ensure fairness and reasonableness in the review procedure.

#### **Article 4: Privacy Protection**

Personal information provided by students will be handled with strict confidentiality during the accommodation assistance process, in accordance with the “Personal Information Protection Act” and relevant university regulations. The information will only be accessible to authorized personnel involved in related operations, ensuring the prevention of data leaks or misuse and safeguarding the privacy rights of students.

#### **Article 5: Gender Friendly Accommodation Rental Subsidies and Arrangements**

1. Students should apply for relevant government accommodation subsidies and submit the required application documents.
2. Financial assistance will be provided to the students who pass the review and are admitted to the gender friendly dormitory arranged by the university. The subsidy amount is the difference between standard dormitory fee of the university and the government subsidy amount, up to a maximum of NT\$3,000 per month for both single and double rooms.
3. If two students submit a joint application, priority will be given to arranging accommodation in a double suite of the same gender.

**Article 6: These regulations shall be implemented upon approval by the Students Affairs Meeting of the Office of Student Affairs, and any amendments will follow the same process.**
