

The Campus Vehicle Management Regulations on Yuan Ze University Headquarters

March 13, 2024, Approved by the 2nd General Affairs Meeting of the 2023 Academic Year

October 11, 2024, Amended by the 1st General Affairs Meeting of the 2024 Academic Year

- Article 1.** To maintain traffic safety, campus tranquility, environmental aesthetics, and parking order within the main campus, these regulations are established. The term "vehicles" as used herein includes cars, motorcycles, bicycles, and electric scooters.
- Article 2.** Cars entering the campus are identified by license plate recognition and charged based on hourly rates, with fee standards established separately. Individuals eligible for preferential access, including full-time faculty and staff and on-campus business operators, may apply for up to two cars; others are limited to one car. Vehicles with preferential access may park in the A-Zone parking lot located to the left of the campus entrance (hereinafter referred to as the A-Zone parking lot) without additional hourly charges. General student cars are restricted to the A-Zone parking lot; entry into the main campus is subject to the hourly parking rate.
- Article 3.** Motorcycles of full-time faculty, staff, on-campus business operators, and students with public hospital-issued disability certifications may enter the campus upon approval. Delivery motorcycles are permitted entry upon obtaining a temporary pass. Other motorcycles are prohibited from entering the campus. Motorcycle identification stickers must be affixed prominently to the front of the motorcycle and must not be loaned or transferred. Delivery motorcycles must adhere to campus-designated delivery times, routes, and locations and are limited to a 30-minute stay within the campus.
- Article 4.** Official vehicles such as postal vans, telecommunications repair vehicles, fire trucks, ambulances, police cars, garbage trucks, cleaning vehicles, Taiwan Power Company service vehicles, courier trucks, and engineering vehicles are exempt from parking fees after verification by gate security.
- Article 5.** Vehicles entering the campus must comply with “Regulations Governing Road Traffic Safety” and must not violate any provisions outlined in the “Road Traffic Management and Penalty Act”. Vehicles must be parked in designated parking lots or spaces (racks). Vehicles classified as special under the preceding article may park at work sites during their operation period, provided they do not obstruct traffic, and are not restricted to designated parking spaces or locations. Vehicles parked in designated spaces (e.g., accessible parking or other reserved spots) must display relevant permits or proof in a clearly visible location.
- Article 6.** During campus-hosted events, vehicles may be allowed free access or charged per entry for the day, subject to specified time limits.

Article 7. Vehicles must observe the campus speed limits: 30 km/h within the main campus and 20 km/h in dormitory areas. Bicycles must be dismounted and walked on downhill pedestrian pathways. Riding against traffic or downhill speeding is prohibited.

Electric scooters are restricted to red brick paths and campus loop roads, riding on the right side of the road. Riders must comply with the regulations for the use of electric scooters, reducing riding speed and yielding to pedestrians. It is strictly prohibited to carry multiple passengers, perform stunts, ride against traffic, or engage in reckless riding.

Underground parking in YZU Buildings 6 and 7 is reserved for faculty and staff vehicles, while delivery vehicles may park temporarily for unloading. Dormitory 3 underground parking is for faculty, staff, and on-campus business operators only.

Parking lots are closed during extended holidays or typhoons and will not accommodate temporary access during announced closure periods.

Car washing is prohibited on campus.

Article 8. Electric-assisted vehicles with government-issued license plates shall be handled in accordance with the relevant regulations for automobiles and motorcycles. If the appearance is similar to that of an ordinary bicycle (with pedals and chains that can be powered by human force), they shall be managed in accordance with the relevant regulations for bicycles. If the appearance is similar to that of an ordinary motorcycle (without pedals and chains that can be powered by human force), they shall be managed in accordance with the relevant regulations for motorcycles.

Article 9. Violating vehicles may be clamped, towed, or ticketed based on photographic or video evidence, with penalties as follows: Cars: NT\$500, Motorcycles: NT\$300, Bicycles: NT\$100. Vehicles with three violations will be blacklisted and denied campus access. Accidents will be referred to the police for handling.

Article 10. Vehicles within the campus that have not been moved for an extended period will be considered abandoned vehicles if, after notifying the owner or issuing a public notice, they remain unmoved during the specified period.

Article 11. These regulations shall take effect upon approval by the General Affairs Meeting and subsequent promulgation. Amendments shall follow the same procedure.

In case of any discrepancy between the Chinese and English versions, the Chinese version shall prevail.
